2019 VENDOR CONTRACT

LAGRANGE CLASSIC MOUNTAIN BIKE RACE VENDOR RULES

VENDOR hereby contracts with the Trinity Trail Alliance for space at the LaGrange Classic Mountain Bike Race as follows:

1. VENDOR agrees to use and pay for booth space as described. VENDOR agrees to accept space assigned and will not sub-let to anyone else.
2. Neither the Trinity Trail Alliance, the LaGrange Classic Mountain Bike Race Committee, nor the County of Trinity will be responsible for any injury which may arise to VENDOR, their employees, agents, guests or customers; or for the loss, theft of or damage to any food, display, merchandise, samples or vehicle from any cause whatsoever while in transit to or from, or while participating in the LaGrange Classic Mountain Bike Race event. By executing this contract, VENDOR agrees absolutely and irrevocably to waive and release any claim it may have against the Trinity Trail Alliance, the LaGrange Classic Mountain Bike Race Committee, nor the County of Trinity, their officers, officials, agents or employees.
3. When ACTS OF GOD or any other causes not within the control of the Trinity Trail Alliance, the LaGrange Classic Mountain Bike Race Committee, and the County of Trinity make it impossible for the VENDOR to occupy the event premises, then in such case the Trinity Trail Alliance, the LaGrange Classic Mountain Bike Race Committee, and the County of Trinity their officers, officials, agents or employees are jointly released from any and all claims for damages which may arise as a consequence thereof.
4. The VENDOR agrees to the following conditions of this contract:
 - All vendor booth space is 10 x 10 unless arrangements for a larger area are made in advance..
 - All vendors are responsible for their own booth set up and take down.
 - Spaces must be kept clean and professional looking. All fire, health and any other laws and regulations applicable to the use of such space type and cost are the responsibility of the exhibitor.
 - Booth spaces must be attended at all times during the event.
 - Compliance with any required licenses and/or sales tax is the responsibility of the exhibitor.
 - VENDOR shall not be entitled to a refund or any part of any fee should he/she, for any reason, is unable to participate after acceptance.
5. FOOD VENDORS also agree to the following conditions of this contract:
 - Only food specified in contract may be sold.
 - FOOD VENDORS shall have appropriate license, insurance, and local health department permit.
 - All pertinent laws, ordinances and regulations pertaining to health and public safety shall be strictly observed.
 - VENDOR will cooperate by keeping Food Vendor area clean.

Event set up begins at 7 a.m. and the event take down is at 4 p.m. Do not be late or leave early. You are responsible for your own pop-ups, tables, chairs and clean-up. Thanks for participating!
